What are Cookies?

Cookies are small data files placed on your computer or mobile device by a website's server when you visit a webpage. These files are stored in your web browser and allow us or third-party partners to recognize your browser and make your future visits more efficient by improving your user experience.

How Do We Use Cookies?

When you access the Service, we may place cookie files in your browser. These cookies enable core functionalities of the Service, such as analytics, storing preferences, and delivering targeted advertisements. We primarily use session cookies. Additionally, we may employ other similar technologies (e.g., pixels, events, screen recordings) to enhance your experience.

Types of Cookies We Use

The following are the main types of cookies used on our Service:

- Strictly necessary cookies: These are essential for logging in, navigating the Service, and
 accessing specific features. These cookies also support security measures, detecting policy
 violations and assisting with security protocols. Consent is not required for these cookies.
- **Functionality cookies:** These cookies help the Service remember your choices (such as language settings) to offer more personalized and enhanced features. These cookies do not track your activity across third-party websites and are used for login authentication and other Service functions.
- **Performance cookies:** These cookies collect information about your interactions with the Service, such as time spent on pages and other behavioral data. We use them for research, analytics, and statistical purposes.
- Targeting or advertising cookies: These cookies deliver tailored offers and ads based on your

interests and are often set by advertisers to gather insights on the people interacting with their ads. They may also limit how often you see certain ads and measure ad effectiveness.

Third-Party Cookies

We may also allow third-party cookies to be placed on your browser. These are used for purposes such as tracking Service usage, delivering targeted ads, and more. Examples include:

- Third-party functionality and maintenance cookies: These cookies help prevent duplicate service offers and assist with bug detection and security.
- Google Analytics: A performance cookie used to gather anonymized information about how
 visitors interact with our website. It helps us improve our Service by collecting data such as

Legal Basis for Processing Personal Data

Under the General Data Protection Regulation (GDPR), the Company processes personal data based on the following legal grounds:

• Consent: We will process your personal data where you have provided explicit consent to

do so. You have the right to withdraw your consent at any time.

- **Contractual Necessity**: Processing is necessary for the performance of a contract to which you are a party, or to take steps at your request prior to entering into a contract.
- **Legal Obligation:** We may process your personal data to comply with a legal obligation to which the Company is subject.
- **Legitimate Interests**: Processing is based on our legitimate interests, such as improving our services, provided these interests are not overridden by your rights and freedoms.

Collection of Data

When you complete our online contact form, we may request personal details such as your name and email address. We only collect this information when you provide it voluntarily. It is important that the information you submit is complete, accurate, and up-to-date, and by doing so, you confirm its correctness. While you are not legally required to provide your personal information, failing to do so may affect our ability to contact you.

If you provide the personal details of another individual to the Company, you guarantee that you have obtained their explicit written consent to share their information with us and allow its use in line with this policy.

The Company may collect information about your activity on our website, including content viewed, session lengths, pages visited, services of interest, your computer's location, and the IP address used to access the website. Additionally, we may gather or engage third parties to collect and analyze anonymous, statistical, or aggregated data related to your use of the website.

Data Retention

We retain personal data for as long as necessary to fulfill the purposes for which it was collected, including to meet legal, accounting, or reporting requirements. The specific retention periods vary depending on the nature of the data and the purpose of its collection.

- **General Retention Period**: Personal data is retained for the duration of your engagement with the Company and for a period afterward as required by applicable law.
- **Retention for Legal Compliance**: Where required by law, we retain your data for the period necessary to comply with legal obligations or in the event of legal claims.
- **Data Minimization**: We aim to keep personal data only for as long as it is needed, after which it will either be securely deleted or anonymized.

Your Rights

As a data subject, you are entitled to the following rights under the GDPR (where applicable):

1. **Right to Information**: You must be informed by anyone processing your personal data about

the type of data collected, its purpose, and any other parties with whom it may be shared.

- 2. **Right of Access**: You have the right to request and obtain details about the personal data a data controller holds about you.
- 3. **Right to Rectification**: You may request the correction or update of any inaccurate or incomplete personal data held about you.
- 4. **Right to Erasure** (Right to be Forgotten): In certain situations, you can request the deletion of your personal data, and the controller is required to comply without undue delay.
- 5. **Right to Restrict Processing:** Under specific circumstances, you can request that the processing of your personal data be temporarily paused.
- 6. **Right to Data Portability**: You have the right to receive your personal data in a structured, commonly used format and to transfer it to another data controller.
- 7. **Right to Object**: You can object to the processing of your data if it is inconsistent with the original purpose for which it was collected, including cases of profiling, automated decision-making, and direct marketing.
- 8. **Rights Related to Automated Decision-Making and Profiling**: You have the right not to be subjected to decisions made solely through automated processing, including profiling.

Third-Party Disclosures

We do not sell, rent, or trade your personal data to third parties. However, we may share your personal data with trusted third parties under the following circumstances:

- **Service Providers**: We may share your personal data with third-party service providers who perform services on our behalf, such as hosting, payment processing, or data analytics. These third parties are contractually obligated to use your data only as necessary to provide the services and are bound by confidentiality agreements.
- Legal Requirements: We may disclose your personal data if required to do so by law or in response to valid legal requests, such as to comply with a subpoena, court order, or government investigation.
- **Business Transfers**: In the event of a merger, acquisition, or sale of assets, your personal data may be transferred as part of the business transaction, provided the recipient agrees to respect your personal data in a manner consistent with this policy.

- 2. Access any of your personal information and verify its accuracy.
- 3. Correct and update your record with personal data if inaccurate.
- 4. Erase data or cease processing, provided there are no legitimate grounds for retaining it.
